I hereby assume all risks associated with my participation in the progressive physical exercise as well as my performance during training & live events. I further agree that my attendance in all matters associated with (PPW) & affiliates shall be at my sole risk and decisions as to whether I participate shall entirely be my responsibility. Furthermore, I agree it is my responsibility to contact a physician prior to beginning all activities associated with (PPW) & its affiliates.

I hereby fully and forever release, discharge, and agree not to sue, Joseph Byrd, Jessica Byrd, Pure Pro Wrestling (hereafter called "PPW"), & Affiliates of Judah Ministries, City Market, and any other hosting location, including their officers, directors, agents, employees, representatives, and successors for any and all claims, causes of action or liability for any injury, loss or damage sustained or incurred by me arising out of or in any way associated with my participation in the progressive physical exercise, performances, & training associated with performances, including all claims, causes of action or liability arising out of the negligence of (PPW) & its affiliates, their agents or representatives.
